











ACHIEVEMENTS

- Cultural Policy and NACZ Act Review Seminar, which brought together 30 national civil society leaders, Arts Council and Government officials and representatives from Arterial Network and the Observatory of Cultural Policies in Africa.
- BAF and the National Gallery in Bulawayo cohosted Annual Lozikeyi Lecture, were Senator David Coltart (Minister in charge of Arts and Culture) was the guest Lecturer, and delivered a presentation on Art and Law, with particular reference on the recent ban of Owen Maseko's exhibition on the Gukurahundi Genocide and Adam Madebe's nude sculpture Looking into the Future

'I know the statue well and I believe that its banning is not only ridiculous but also a violation of our fundamental constitutional rights. The statue is not promiscuous or suggestive in any way—it is simply an interpretation of the male human body. It is also of course a fine work of art and we can be justly proud that a Bulawayo citizen is responsible for it.'

Senator David Coltart

Senator Coltart went on to say that as a member of the Cabinet responsible for this banning he could not say what should be done about this. Suffice it to say that as Minister of Arts and Culture he does not support the banning and believe that it constitutes a fundamental and serious breach of artistic freedom as enshrined in the Constitution.

Owen Maseko

It is a shame that almost all of the discussion pertaining to Owen Maseko's exhibition has been corralled by political imperatives. Zimbabwean artists work at a challenging interface between the social/cultural and the political; but as artists, they are also positioned within the broader discipline of 'Art', a field unconstrained by national boundaries and rigid definitions of 'sovereignty'. The controversy surrounding Maseko's exhibition has effectively cast him as a 'political activist' and fails to give due recognition to the fact that he is also, quite simply, an Artist.

The Coalition against Censorship Zimbabwe (CACZ) is an alliance of the Zimbabwe Theatre Association (ZiTA), Bulawayo Arts Forum (BAF), Visual Art Association Bulawayo (VAAB), Savanna Arts Trust, Global Arts Trust, Homegrown Arts and Nhimbe. CACZ is dedicated to protecting free creative expression by:

- Providing educational resources, training and advocacy support to individuals and organizations responding to incidents of artistic censorship.
- Educating and empowering art creators, promoters and consumers to defend creative freedom.
- Documenting and reporting on current censorship issues and violations on free expression.
- Working to influence policy positions and judicial opinions about free expression and access to information by submitting amici briefs.

Defending someone's right to speak doesn't mean you agree with what they say. Defending the right to read a particular book, or view a work of art or a film, doesn't mean you like it or agree with its message. Recognizing that others have different views about art, politics, literature and religion, and that their views are entitled to the same respect and protection as your own, is a form of tolerance required of all in a pluralisticsociety.



EURO-AMERICA VII CAMPUS: A relationship in the making...

The Nhimbe Director Josh Nyapimbi attended the 7th Euro-American Campus on Cultural Cooperation held in Las Palmas, Gran Canaria (Spain). The Euro-American Campus is a residential meeting between people from the field of culture and international cooperation whose projects or institutions could belong to this space, as well as interact and strengthen their relationships. The general theme of the Campus was "Culture, Cooperation and Local Development", with a main focus on cultural practice. It was the first time that the Campus had representation from Africa. Useful contacts were made. Potential partnerships will be followed up in 2011. We are grateful to Tony Murphy, Nicolette du Plessis and the Canary Islands Government for facilitating and funding the trip.

OVC Program rebrands to VaVeZi

The Nhimbe OVC Program is now formally constituted as Vana veZimbabwe (VAVEZI) and registered PVO 36/10. VAVEZI will continue to pursue the following objects:

- To provide support for access to health services for Orphans and other Vulnerable Children (OVC) infected or affected by HIV and AIDS.
- To support activities designed to promote food security for Orphans and other disadvantaged children.
- To provide school fees, uniforms, stationery and other educational needs for OVC.
- To provide Adolescents with Sexual and Reproductive Health information and services to enable them to make well-informed choices about their SRH and decrease their risk of STIs and HIV infections.

Why did Nhimbe establish VAVEZI?

- Growing number of OVC within the Nhimbe Arts Education Program.
- School-based Arts Education, Psychosocial Wellbeing and Adolescent Sexual and Reproductive Health are indivisible, interdependent and interrelated.

ACHIEVEMENTTO-DATE (2003-2010):

Geographical Coverage: Bulawayo (Urban) Umguza (Rural) and Umzingwane (Rural)

- **EDUCATIONAL SUPPORT:** 150 children received School Fees, Uniforms, Stationery
- **EDUCATIONAL CAMPAIGNS:** 20,000 children received information, education and resources on HIV and AIDS, Sexual and Reproductive Health.
- **HEALTH SERVICES:** 6 Youth Friendly Corners (3 furnished) set up at 6 Clinics in Umzingwane District.
- **LIFE SKILLS**: 20 Nurses, 50 Teachers and 30 Out of School Youth receive training on OVC Psychosocial Support, Child Protection and Support, Children's Rights and Adolescent Sexual and Reproductive Health
- **HUMANITARIAN-RELIEF SUPPORT:** 150 Children received food aid (2007/8). 50 Children received clothing in Umquza.






Vana veZimbabwe
